1. Verified that the door is unlocked.
2. Meeting called to order @ 5:00 p.m. by Chairman Richard Thoman.
3. **Approve minutes of previous regular meeting:** Motion to approve minutes of the previous meeting and the meeting minutes from the October 21 meeting by Dawn Sass; 2nd by Isaiah Carlson. Motion carried on voice vote.
4. **Review emergency management updates:** Emergency Management (EMG) Director Gary Ziegler advised the committee on EMG/EMPG Grant information, trainings, and initiative updates.
5. **Review and possible approval of the Hazard Mitigation Grant Program (HMGP) plan proposal through Southwest Wisconsin Regional Planning Commission:** EMG Director Gary Ziegler and Sheriff Kanable updated the committee on the proposal for the creation of the Green County FEMA-approved Mitigation Plan that will be contracted out to Southwestern Wisconsin Regional Planning Commission. The total fee for the project is \$45,000.00 and will be split between this year and next year with a proposed project start date of April 1, 2026 and completed April 30, 2027.

Dawn Sass made a motion to approve the project; 2nd by Isaiah Carlson. Motion carried on voice vote.
6. **Training Requests:** Sheriff Kanable had the following training requests:
 - 1) A Deputy to attend 4th Annual Peer Support Conference in WI Dells, WI from March 2 – March 4 with two overnights and a registration fee of \$150.00;
 - 2) A Detective to attend WI Traffic Safety Officer's Conference (WTSOA) in WI Dells, WI February 23-February 25, with two overnights and a registration fee of \$250.00Isaiah Carlson made a motion to approve the training request; 2nd by David Tschudy. Motion carried by voice vote.
7. **Review jail population and jail medical issues:** Sheriff Kanable updated the committee on the jail population and medical incidents for the month of December.
8. **Review building project updates:** Sheriff Kanable provided updates on the building project and upcoming meetings.
9. **Review and approve Sheriff Office updates:** Sheriff Kanable updated the committee on the patrol activity, staffing and dispatch operations for the month.
10. **Review monthly budget:** Sheriff Kanable advised that the department has spent about 96% of the budget thus far this year and Emergency Management has spent 96.8% of their budget.
11. **Audit bills:** The department bills were reviewed and signed. A motion was made by David Tschudy to approve the bills; seconded by Isaiah Carlson. Motion carried on voice vote.
