7. SCWRTC Financial Report - Treasurer.

Schafer presented the cash flow and 2022 year-end financial position. PRTC's 2022 final financial position was under budgeted expenditures by \$419. A CD is coming due in 2024 and Schafer will look at penalties for closing early and moving this money to a place where it will accrue greater interest. There were three bills for payment: Q4 Administration (\$1,250) to Southwestern Wisconsin Regional Planning Commission and two Boardman and Clark invoices for legal counsel (\$294.00 and \$357.00). Olson asked about the "Draw from Savings" line in the Balance Sheet Revenue, which reflects the requirement to draw on savings since the SCWRTC has no revenue source other than bank interest.

8. WisDOT Report – Lisa Stern, WisDOT.

The City of Madison has sent out the first set of letters of encroachments along the SW Commuter path. Kim Tollers has been hired as a consultant to assist DOT. HNTB has submitted their analysis of the cost options for the Round Grove Bridge. Olson asked that an at-grade crossing be considered for the Round Grove bridge to provide a full range of options. Stern responded that this may incur significant grading work and involve real estate options.

9. WIDNR Report - Drew Hanson, WIDNR.

The at-grade crossing at Round Grove Road is going around the previous bridge site and enables snow mobile and bike crossing at Round Grove Road. DNR Staff completed fall ditch mowing of the trail. There was a partial tunnel collapse of the brick portion of the Stewart Tunnel. The Stewart Tunnel project presented last summer and funding for this is included in the Governor's budget. Hanson is passing his role as DNR representative to SCWRTC off to Sara Rigelman, who will serve going forward.
