Chair Guth called the meeting to order at 5:00 PM.

Motion by Leonard, seconded by Tschudy to approve the minutes of the April 26, 2023, meeting. Motion carried on a voice vote.

Motion by Mandel, seconded by Boll to authorize hiring of a WIC Director up to Step 7, pending oversight committee approval (Exhibit 1). Motion carried on a voice vote.

Motion by Boll, seconded by Tschudy to approve elimination of Nurse Educator position and creation of Nursing Home Educator position (Exhibit 2). Motion carried on a voice vote.

Motion by Thoman, seconded by Leonard to approve the IT-01-Information Technology Policy updates as presented (Exhibit 3). Motion carried on a voice vote.

Chair Guth read the statement of purpose for the closed session under Wis. Stat. 19.85(1)(e): Deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session, Specifically: Discussion and possible action regarding compensation increases for sworn Green County Sheriff's Office staff and dispatchers. **Motion by Tschudy, seconded by Thoman to enter into closed session. Motion carried on a unanimous voice vote.**

Motion by Leonard, seconded by Tschudy to enter into open session for discussion and possible action regarding items discussed in closed session. Motion carried on a voice vote.

Motion by Furgal, seconded by Mandel to approve the proposal for wage modification and MOU and eliminate 8-hour comp time carryover provision (Exhibit 4). Motion carried on a voice vote. Motion by Tschudy, seconded by Mandel to approve moving Lieutenants from Grade 22 to 23, Chief Deputy from Grade 25 to 25b, and a \$1 across-the-board increase for Dispatchers. Motion carried on a voice vote.

Motion by Boll, seconded by Thoman to approve the reclassification of the following Human Service Positions, effective the first day of the next pay period: Community Support Program Supervisor, Comprehensive Community Services Supervisor, Mental Health Supervisor, Mental Health Therapist II (Certified), and Comprehensive Community Services Mental Health Professional (Exhibit 5). Motion carried on a voice vote.

The committee discussed the request from UW-Extension to budget for county employees and county board members to participate in Green County Leaders. No action was taken. Staff to discuss at the next department head meeting.

HR Director Delores Merrick provided updates on the Personnel subcommittee. Overtime and Comp Time reports and exit interviews were distributed. No action was taken.

Motion by Tschudy, seconded by Mandel to approve the bills as presented (Exhibit 6). Motion carried on a voice vote.
